THE NET MEETS EACH THURSDAY AT 8:00 PM LOCAL TIME ON 145.450MHz WITH A TONE OF 192.8. ALTERNATE FREQUENCIES ARE 147.075 WITH A TONE OF 103.5 AND 145.450 SIMPLEX. THIS IS A DIRECTED NET. PLEASE DO NOT TRANSMIT UNLESS DIRECTED TO DO SO BY THE NET CONTROL STATION, OR IN CASE OF EMERGENCY.
